

## **TERMS AND CONDITION OF SALE**

All business with RADIX HUNTING & STIC-N-PIC is subject to the Terms and Conditions set forth below. By purchasing any sum products from RADIX HUNTING & STIC-N-PIC, the Buyer agrees to the following Terms and Conditions - which may be updated and/or modified at RADIX HUNTING & STIC-N-PIC' discretion at any time. These Terms and Conditions constitute the entire agreement between RADIX HUNTING & STIC-N-PIC and Buyer, and supersede any and all prior or contemporaneous agreements, warranties, representations, and understandings with respect to the goods, services and information.

## **SATISFACTION GUARANTEE**

RADIX HUNTING & STIC-N-PIC offers a 30-day satisfaction guarantee. If for any reason Buyer is not completely satisfied with products purchased from RADIX HUNTING & STIC-N-PIC, Buyer may return products within 30 days of purchase for a full refund of the purchase price and applicable taxes - subject to the following conditions: Hardware products must be returned in original packaging and must be complete and in "new" condition. Any damaged or worn products may be subject to a restocking fee of 25% of the original purchase price. Buyer must obtain a Product Return Authorization (PRA) number for all products returned under this money-back guarantee. A PRA may be obtained by calling RADIX HUNTING & STIC-N-PIC at 1-888-276-4072. Buyer must return original CD's containing RADIX HUNTING & STIC-N-PIC software and will be required to sign an affidavit indicating that all copies of RADIX HUNTING & STIC-N-PIC software have been removed from Buyer's computers & electronic devices and any physical copies of the software have been properly & securely destroyed. Any and all shipping charges will not be refunded for any reason.

## **LIMITED WARRANTY**

RADIX HUNTING & STIC-N-PIC hardware products are warranted for one (1) year. If during this period, through normal use, a hardware product becomes defective due to defects in materials or workmanship, RADIX HUNTING & STIC-N-PIC will either repair or replace the product. This warranty is void if a product failure results from accident, abuse, improper use, negligence by Buyer, improper use by person connected or not connected to Buyer by means of family or friendship, disassembly, or unauthorized maintenance or repair. Software products are licensed to Buyer under the terms of the applicable RADIX HUNTING & STIC-N-PIC software license (contained within installation programs). If a user wishes to review the software license agreement before purchasing products from RADIX HUNTING & STIC-N-PIC, a copy of the software license may be obtained by request. Buyer must obtain a Product Return Authorization (PRA) number from RADIX HUNTING & STIC-N-PIC before returning any product(s)

for repair or replacement. If RADIX HUNTING & STIC-N-PIC concludes that a returned product is not defective, Buyer will be notified, the product will be returned to Buyer at Buyer's expense, and Buyer may be charged for RADIX HUNTING & STIC-N-PIC' examination and testing of the product. This limited warranty is the sole warranty for hardware and software products offered by RADIX HUNTING & STIC-N-PIC and RADIX HUNTING & STIC-N-PIC shall not be liable for any amounts for said product(s) except in compliance with this warranty.

## **CREDIT CARD PAYMENTS**

When making credit card purchases, Buyer represents and warrants that: (i) the credit card information supplied by Buyer pursuant to this Contract is true, accurate, correct and complete, (ii) charges incurred by the Buyer pursuant to this Contract will be honored by the Buyer's credit card company or will be promptly paid for by Buyer in readily available funds before RADIX HUNTING & STIC-N-PIC has any further obligation to perform under this Contract; and (iii) Buyer shall pay charges incurred by Buyer pursuant to this Agreement in the amounts in effect at the time incurred, as posted on this website, including all applicable taxes. Buyer shall be responsible for all charges incurred through the usage of Buyer's credit/debit/charge card(s) and/or PayPal account (or comparable), whether or not such charges were authorized by Buyer. Buyer agrees to keep his or her credit/debit/charge card(s) and/or PayPal account (or comparable) confidential. RADIX HUNTING & STIC-N-PIC shall have no obligation to protect Buyer from unauthorized use of Buyer's credit/debit/charge card(s) and/or PayPal account (or comparable), but shall honor reasonable credit/debit/charge card(s) and/or PayPal account (or comparable) change requests of Buyer.

## **TAXES**

Product prices do not include applicable sales, use, service, value-added or like taxes. Buyer shall pay all applicable sales, use, service, value-added or like taxes, unless Buyer has directly provided RADIX HUNTING & STIC-N-PIC with an appropriate and acceptable exemption certificate from the applicable taxing authorities. Buyer shall indemnify and hold RADIX HUNTING & STIC-N-PIC, their members, and managers harmless, with respect to any taxes. Buyer agrees to pay any applicable sales, use, service, value added or like taxes and reimburse RADIX HUNTING & STIC-N-PIC for any of those taxes paid by RADIX HUNTING & STIC-N-PIC.

## **DELIVERY, TITLE and INSURANCE**

RADIX HUNTING & STIC-N-PIC shall deliver the products to a commercially reasonable carrier (a "Carrier") at RADIX HUNTING & STIC-N-PIC' facility for

shipment to Buyer and, if Buyer requires that the products be delivered outside of the United States, RADIX HUNTING & STIC-N-PIC shall arrange for a Common Carrier to Buyer's foreign location. All deliveries shall be by FOB Origin (based on applicable RADIX HUNTING & STIC-N-PIC Location). Shipments shall be scheduled after acceptance of Buyer's orders by RADIX HUNTING & STIC-N-PIC and receipt by RADIX HUNTING & STIC-N-PIC of necessary and/or requested documents from Buyer. For all deliveries, Buyer shall pay, or reimburse RADIX HUNTING & STIC-N-PIC for, all applicable freight charges, insurance, applicable import duties, and other related fees and shall be responsible for carrying out customs formalities and clearance. Buyer shall be solely responsible for insuring products during transit and for transit delays. Buyer is responsible for inspecting any delivery in a timely manner and any claims for any product shortage, defect or damage shall be deemed waived unless presented to RADIX HUNTING & STIC-N-PIC in writing within 45 days of shipment.

## **CANCELLATION/ CHANGE POLICY**

RADIX HUNTING & STIC-N-PIC may terminate any order if any representations made by Buyer to RADIX HUNTING & STIC-N-PIC are determined to be false or misleading. Changes to orders shall not be binding upon nor be put into effect by RADIX HUNTING & STIC-N-PIC unless confirmed in writing by RADIX HUNTING & STIC-N-PIC' designated representative. In such event, and if said change results in a lesser charge to Buyer, RADIX HUNTING & STIC-N-PIC shall issue the Buyer a credit less any and all shipping and handling charges incurred.
